**ME** AND YOU AND A STATION NAMED BOO: Although this week's new flock of country conversions are getting all the attention--WRBQ-FM Tampa, WQMX Akron, and both WRHP and WKFM Syracuse among them--the most interesting format change to report this week is at suburban Philly/Trenton outlet WBUX Doylestown, PA, which has been evolving into an all-'70s format since late last year, and which M Street heard segueing from "The Candy Man" into "Love Takes Time" last weekend. Or maybe it's the new WCNV Charlotte, NC, (the former WCNT), which returns to the air this week owned by a religious group, but which will do a mostly secular all-news format. #### WASHINGTON THIS WEEK

At press-time, both R&R and Inside Radio were reporting that Senate Commerce Communications Subcommittee staff counsel Antoinette Cook will finally get the nod as FCC chairman, although R&R also suggests that the Clinton administration may wait to announce the nomination alongside the vacant non-Democratic FCC commissioner slot. Cook is in the process of having her first child now, meaning that she probably hasn't hired a nanny yet and would pass Senate muster.

Emmis's WCDJ, Boston MA, license has been renewed, but not without an \$18,750 fine for EEO violations for poor records and recruitment efforts. The license renewal is subject to EEO reporting conditions. Local chapters of the NAACP filed the petition to deny WCDJ's license renewal, alleging that the station's 1988-1991 EEO performance and 1990 renewal application indicated it was not operating an EEO program. Emmis countered, saying the NAACP failed to demonstrate employment discrimination, that the records indicated compliance with the EEO rule, and the unconditional renewal was warranted. The NAACP then withdrew its license challenge.

The National Assn. of Broadcasters sent a letter to the full House and Senate on April 2 attacking the proposed "Sensible Advertising and Family Education Act (S.647) which would force alcohol adds to carry a rotating series of disclaimers. NAB claims the bill will mean a loss of advertising revenue that would drive sports away from free radio/TV toward pay services. The NAB has also come out in favor of FCC efforts to establish a single standard for AM stereo.

R&R reports that the FCC has ordered a license renewal hearing for EZ Communications' WBZZ Pittsburgh, despite simultaneously throwing out many of the issues raised by challenger Allegheny Communications Group stemming from the late-'80s Liz Randolph sex-discrimination/wrongful termination suit. EZ tells R&R that it hopes the Allegheny challenge will be thrown out on technical grounds.

The Commission has designated for hearing the mutually exclusive applications of Raymond W. Clanton and Loren F. Selznick for 103.7 MHz in El Rio, CA.

#### ELSEWHERE

By the time you read this, Christian outlet WNQM Nashville should be back on the air following an April 4 fire that leveled that station and its co-owned shortwave outlet WWCR. No cause was known for the fire at press-time. WWCR won't be back on for at least several weeks.

ABC has finally announced that former KKDA-FM Dallas morning man/WGCI-FM Chicago p.m. driver Tom Joyner will start doing a national morning show for Satellite Music Network at the beginning of '94. Joyner will appear on WGCI-FM through the end of the year as well as on his CBS syndicated countdown "On The Move." Joyner is already out the door at KKDA.

In other morning network news, former WYNF Tampa morning men Ron & Ron, who disappeared from both that station and simulcast WDIZ Orlando last month, have signed a new deal with Bud Paxson. Sometime this month, the duo will start broadcasting from St. Petersburg to Paxson's WZTA Miami, WAIA Jackscnville, and WVRI Orlando. WVRI, a longtime AC, will switch formats to coincide with the change; programming veteran Buzz Bennett is involved as a consultant here. Ron & Ron won't be on in Tampa for the time being because of a non-compete with WYNF owner CBS.

In. LMA/duopoly news this week: Golden West is selling its Seattle combo KVI/KPLZ to Fisher Broadcasting, owners of KOMO-AM-TV. No price was announced for the sale which gives Fisher an AM/AM duopoly.

A month after his agreement with the Business Radio Network collapsed, Pete Rose moves his daily show to the Sports Entertainment Network. Rose will now be heard 6-8 p.m. Eastern on SEN. BRN will not, contrary to rumor, fill the time by playing Kenny Rogers' "The Gambler" for two hours.

Following last week's reports of an ABC-BBC newsgathering alliance, American Public Radio has sent a memo to its affiliates assuring them that APR will continue to distribute the BBC World Service Programs. ABC's deal is with the domestic wing of the BBC.

Eight-hundred and eighty-nine entries have been received for this year's Mercury Awards for creative radio advertising, twice what the RAB/Radio Creative Fund project received last year. The winners will be announced in New York on June 9.

#### WASHINGTON THIS WEEK

Sherrie Marshall, who steps down as an FCC commissioner on April 30, has announced that she will start her own L.A.-based firm--The Marshall Co.--which, according to her statement, will "provide strategic planning, policy and acquisition advice to entertainment and communications companies on the emerging global, multimedia marketplace." Marshall will also become a consultant to the L.A.-based entertainment law firm of Ziffren, Brittenham, and Branca.

As it has in the past, the National Assn. of Broadcasters again came out against four new proposals for satellite digital radio services. NAB calls the proposed services "wildly premature" until the FCC develops a comprehensive DAB policy that would protect existing broadcast stations. The four companies involved are Primosphere L.P., Digital Satellite Broadcasting Corp., Sky-Highway Radio Corp., and American Mobile Radio Corp.

The Commission's Review Board added misrepresentation and lack of candor issues against Gulf Breeze Broadcasting Company for issues during their hearing for a new FM in Gulf Breeze, FL. The Board also enlarged issues against Sample Broadcasting Company, L.P. to determine programming and misrepresentation issues during their hearing for a new FM in Eldon, IA.

Hearings have been designated for mutually exclusive applications of Adam D. Gearheart and Robert G. Picklesimer for a new FM station at Harold, KY; and Rural Initiatives for Shelter and Education and American Indian Broadcast Group, Inc. for a new FM station in Hartford, MI.

Silent stations, beware! WKLO Danville KY and WJHH Soperton GA have been silent since 1989 and 1990, respectively. The Commission has asked the licensees to sniw cause why the licenses should not be revoked.

#### ELSEWHERE

On April 12, Arbitron announced that it was delisting Spanish language KWAC Bakersfield, Calif., for ratings distortion. The next day, the ratings service went further; it has filed a civil suit against KWAC in U.S. District Court asking 550,000 in actual damages and unspecified punitive damages. Arbitron claims KWAC (cash premiums are mailed to potential diarykeepers). All one needs to file with the Commission is "1) An opening statement requesting migration; an accurate description of the existing band station (call sign, community of license and operating frequency) seeking to migrate; and a statement as to whether the petitioner intends to use AM stereo." There is no fee required with the application. with the application.

#### WASHINGTON THIS WEEK (cont'd)

The Commission has denied Pike Family Broadcasting further review of its application for a new FM on 99.5 MHz in Rancho Mirage, CA. Under the "hard lock" processing rules that were in effect at the time of the application, Pike didn't timely comply with power and height limitations in the U.S./Mexico agreements.

#### ELSEWHERE

Since the three-book-a-year idea didn't work last time, but the new, more dynamic Arbitron folks are back with a new suggestion that would eliminate quarterly ratings in the 96 continuous measurement markets. The proposal--developed in conjunction with the Arbitron Radio Advisory Council--would switch the survey period from 12 weeks to 18 weeks. Rolling averages covering 18 weeks would be delivered every six weeks electronically, allowing the printed book to be whittled down to a smaller "Radio Buyer's Guide." Some ADI and TSA sample would be moved to a market's metro; this, along with the longer ratings period, would increase sample size by 70%, according to the ratings agency. Arbitron will be looking for customer feedback over the next six months from NAB, RAB, ad agencies, and others. It could be ready to move by this summer if people say yes.

Ex-WKYS Washington, D.C., night jock Kevin James has filed a \$1.2-million lawsuit against his previous station claiming, among other things, breach of contract, fraudulent inducement, and invasion of privacy. James, host of the station's nightly "Quiet Storm"-type program, claims that WKYS didn't given him the amount of programming freedom they'd promised. And that the station broke into his locker and dubbed his personal carts--not, presumably, including "Locking Up My Heart" by the Marvelettes.

ABC Radio Network has cut a deal with the Scientific Atlanta people, picking up new SEDAT receivers allowing it to send out 102 satellite channels, thus doubling its satellite distribution abilities. ABC will provide SEDAT II cards as well as new dishes to many of its affiliates, particularly SMN outlets.

#### WASHINGTON THIS WEEK

The sale of Jacor Communications to the Zell/Chilmark Fund, L.P., something which had threatened to bog down in the fighting between Jacor and Bud Paxson, has been approved by the FCC. Zell/Chilmark now owns 93.48% of Jacor's voting shares.

The Commission has ordered two silent AM's to show cause why their licenses shouldn't be revoked. H. Gibbs Flanders Jr.'s WJHH Soperton GA has been off the air since June 8, 1990. Honus Shain's WKLO Danville KY has been dark since August 18, 1989.

#### CANADA THIS WEEK

The Canadian Association of Broadcasters and the CBC have teamed up to launch experimental digital radio service under the name Digital Radio Research, Inc. DRRI, which will be based in Montreal, has an initial \$2.3-million (CDN) budget drawn from CBC, government, and private broadcasters. It plans to launch experimental L-band digital stations in Montreal and Toronto by late '93. Meanwhile, back in the states, while the USA Digital folks did manage a demonstration of their IBOC AM Digital system, a planned DAB bus demonstration of FM technology fell through due to "technological difficulties unrelated to the DAB technology. USA Digital tells R&R that it may or may not try to recreate the experiment; its plans depend to an extent on what the National Radio Standards Committee decides on DAB testing at its May 3 meeting.

Canadian FM broadcasters got a few more presents from the CRTC this week when the regulatory agency dropped the requirement that FM stations be at least 15% spoken word and devote at least three hours to newscasts per week. The CRTC also dropped the limit on the amount of advertising an FM can accept and is also now allowing college stations to broadcast up to 504 minutes of ads a week, including 126 minutes of traditional spots with the remainder to consist of the paid sponsorship announcements that U.S. non-commercials can run.

The Interep Radio Store has entered into an agreement with Toronto-based Target Broadcast Sales which will now represent Interep's client stations to Canadian broadcasters.

#### ELSEWHERE

The spectacular February jump in ad revenue has been followed by a respectable March according to the Radio Advertising Bureau. Combined local and national revenue for March is up 13% over a year ago. Local revenue for the month is up 13% over March '92 with the Southwest leading the way at 22% and the west having the smallest increase at 9%. National revenue is up 11% with double-digit rises in the east and west. Comparing the first three months of '93 to the first three months of '92, local revenue is up 10%, national revenue is up 6%. Network revenue is up 5.1%.

In yet another action involving a Spanish-language outlet, Arbitron has slapped KRAY-FM Salinas, Calif., with a page 5(B) note for running an "if anybody asks what station you listen to..." promo that also includes instructions to "write it down in your diary."

In this week's LMA/duopoly news: The owners of WMXB Richmond have petitioned the FCC to deny the sale of Capitol Broadcasting Co.'s WRNL/WRXL Richmond to Clear Channel as a duopoly partner for WRVA/WRVQ. WMXB contends that even though the four stations add up to 24.7% of the local audience, they would at other times be over 25%.

Also, the LMA between Honolulu's KINE and KPOI has ended. KINE has moved in with crosstown KULA/KRTR although folks at the latter station insist there's nothing more to it than a rental of studio space. Also recently closed: the duopoly sale of KLCI Boise to crosstown KBOI/KQFC; the merger of WCMF and WRMM Rochester, N.Y.; the merger of WSSH-FM and WBOS Boston under Granum; and the purchase of suburban Seattle's KBRO by KKMO Tacoma.

By age 12, most DX'ers have figured out that TV channel 6 will show up on their FM radio just below 88.1. This is handy if you want to watch something on channel 6 that comes on after you're supposed to be in bed, but it's something that had been pretty low utility for the rest of us. Now, Spokane's KHQ-TV-6 is promoting the availability of their programming on FM, billing the signal as KHQ-FM 87.7. Most of the promotion centers around the availability of KHQ's newscasts on the radio.

In the newest of its collection of radio listener studies, Paragon Research reports that 64% of the 400 respondents it surveyed say they would like stations to play more than one or two cuts off an album. They also report that 64% of respondents are in favor of less repetition, something will come as no surprise to most of you whose listeners really DO think songs get played once an hour. And only a third of the sample think stations play too much unfamiliar music. There is one contradictory finding, however, which is that when this question is rephrased, only 21% are in favor of more unfamiliar music. This would indicate that listeners are confused. And since we all know that radio is sort of confused these days, we can perhaps intuit that radio is finally making good on its stated goal of just giving listeners what the research shows that they want.

WEAZ-FM Philadelphia has dropped its longtime EZ101 handle (with its calls to follow as WBMB). It is now known as B101.

Jeffrey Lyons, known for his work with WCBS THP as well as CNBC and the "Sneak Previews" TV show, is now syndicating his trademark "The Lyons Den" short-form entertainment feature through Murray/Walsh Radio Programming. The three-minute daily show launches May 24; for info, call 800-729-6499. Also, the firm that syndicates the "Blues Deluxe" program should have been shown last week as Music UNLIMITED. Call 817-261-3520.

J. William Grimes, president/COO of Multimedia, becomes president/CEO of the company. Walter Bartlett, former chairman/CEO will remain Chairman of the board at Multimedia ... At the ABC Radio Networks, Joan Kessler, publisher of Capital Cities' Growing Majority Magazine, transfers in as director of merchandising. Also, WAPI-AM-FM Birmingham, Ala., ND Ted Randall is the new ND for the networks. And Sr. VP/engineering P. Kent Coughlin has retired from ABC after 35 years.
