Public radio's land-grab threatens the FCC's Dec 5 FM Auction of 350 CPs

What a mess! The D.C. Circuit Court of Appeals just threw a large-size monkey wrench into the FCC's plans for FM Auction #37 (which has already been delayed for months). National Public Radio and other pubcasters claim they're running short of spectrum in the "reserved" NCE band between 88.1 and 91.9 MHz. They want to compete for new FMs from 92.1 up to 107.9. But the appellate court just ruled (on July 3) that Congress in "plain language" exempted pubcasters from auctions in the 1997 Balanced Budget Act. Now what? Run an auction for commercial applicants, but something else for pubcasters? Some attorneys speculate that the ruling will embolden pubcasters to file on commercial-band opportunities they'd never thought about before. The Commission may have to pull any frequency where there are both commercial and non-com applicants. The court decision is No. 00-1246.

Arbitron's RADAR screen gets bigger

Arbitron pays SRI \$25 million for the business segment that produces the respected quarterly "RADAR" measurements for the radio networks. The deal makes Arbitron just as big in the sales network business as it is in the 280 markets where it conducts local radio research. There was lots of immediate chatter about converting RADAR from its current telephone-based methodology over to Arbitron's diary system – greatly enlarging the sample size. But M Street believes Arbitron will move very, very cautiously. It has already taken over the 21 employees based at SRI facilities in Westfield, NJ, and that's where Arbitron senior exec David Lapovsky now hangs his hat, instead of Arbitron's office in Manhattan.

Census Shakeup

Fasten your seat belt: the 2000 Census data is coming to the Arbitrons. But it's arriving in two separate waves, beginning with the Fall 2001 Arbitrons, and lapping over into Winter 2002. Some markets will experience jagged changes over at least six months, and that could make Arbitron's life difficult for a while. Not to mention subscribers: As Arbitron's data supplier Market Statistics plugs in 2000 Census data, it will adjust its previous assumptions about African-American and Hispanic populations.

The issue gets extremely technical, but we forecast a bumpy ride in some markets. For example: The Census count for Dallas-Ft. Worth Hispanics is 32.2% larger than the estimate from Market Statistics. In San Francisco, Market Statistics overestimated the black population by 8.6%, compared to the Census.

WASHINGTON THIS WEEK

The floodgates of Low Power FM have opened up, and some very large markets are getting new **IOO-watt LPFMs.** Literally a couple of hundred LPFM CPs have been received by the FCC for possible grants in 19 states — even in some big markets like Philadelphia, Phoenix, and Charlotte. In Philadelphia, three CPs have been received, for 88.5, 90.5 and 105.9 MHz. In Phoenix, a Spanish church applies for an LPFM at 88.7. In Charlotte, the Lake Wylie Community Radio Project wants 93.7. In Raleigh, Triangle Access Broadcasting wants 107.9. In Nashville, David Lipscomb University wants an FM at 98.7. In Des Moines, Drake University wants 94.1. State governments are also claiming stations - in Vermont and New Mexico, LPFMs have been filed for by state highway departments. There is one LPFM app even the NAB might support. It's 102.3 in Bellingham, WA - requested by the American Museum of Radio (Take a closer look at radio history: visit the American Museum of Radio's website @ http:/ /www.antique-radio.org).



Republican Commissioner Kevin Martin is finally sworn in. So the FCC has now attained its 3-2 Republican majority. Martin has begun a full five-year term that seats him at the Portals until mid-2006. M Street spots some "Carolina

Blue" at the FCC: Both Martin and new Democratic Commissioner Michael Copps are products of the University of North Carolina at Chapel Hill, though many years apart —Copps was already studying at North Carolina when Martin was born.

The FCC's indecency push — to the extent there is one — is coming from the Dems, not the Republicans. Complaints about Mancow Muller's discussion of sex between a 27-year-old and a 9-yearold on WKQX, Chicago got a dismissal from the FCC's Enforcement Bureau – but Democrats Gloria Tristani and Michael Copps howled. Copps is actually suggesting that the FCC require all stations to run aircheck tapes. His quote: "I am interested in looking

at how the Commission could encourage universal retention of recordings of broadcast programming to aid in its indecency enforcement." Sounds as if Tristani has a vocal new ally.



"When you're giving a station the death penalty, exculpatory information" should be examined.

That's former licensee Mike Rice, who tells M Street that during the original license revocation hearings, the FCC never got to hear information about his mental condition (bipolar disorder) and his undiagnosed alcoholism. Now Rice has a new law firm (Cohn and Marks) and a new line of defense. The convicted sex offender's "Petition for Equitable Relief" was rejected by the FCC following the Supreme Court's March 19 refusal to take his case. Rice says he's been in radio since 1968 and would be lost without a connection to radio. The licenses controlled by Rice-owned companies like Contemporary Media and Lake Broadcasting have been listed for auction by the FCC. The AM licenses are Terre Haute's WBOW at 640 and WBUZ at 1230 and they'll go into Auction #32, but the FCC needs a supplemental filing window to get them in. The FMs, like modern AC WZZQ, Terre Haute, are being tossed into the controversial Auction #37, now bumped to December 5. Rice gets a Special Temporary Authorization to continue running the stations for up to 90 days, while the FCC locates an interim operator. Our guess is, the "interim operator" could be in for a long run.

FCC Chairman Powell faces a

big test of wills with the House over EEO. House Republican leader Mike Oxley urges the FCC to drop the EEO fight and tells Powell the federal Equal Employment Opportunity Commission and the DOJ already have the field covered: "Broadcasters are fully subject to



the same federal and state anti-discrimination laws as all other employers." He insists that the FCC's most recent EEO attempt was "both redundant and unnecessary." Powell vows to make a third attempt to create constitutionally-valid EEO regulations for broadcasting and cable.

Peter Doyle rises to Chief of the FCC's Audio Services Division. That puts Peter in charge of the unit that regulates AM, FM, FM translator and FM booster services —handling all sales, license renewals and facility modification requests. Larry Eads ran Audio Services for most of the '90s. Audio Services reports to Mass Media Bureau Chief Roy Stewart. Radio Disney goes worldwide. Michael Eisner says 48 markets in the U.S. and a

new Radio Disney outlet in Buenos Aires are just the beginning – the Disney chief lays out



his broad vision: "During the next few years, we plan to expand across South and Central America and Mexico, as well as Europe and Asia." The purpose is the same that Radio Disney serves here in the U.S.: "This is significant as a business opportunity and it is significant for the Disney brand." And that's what it's all about — the Disney brand.

Glenn Fisher sells his syndication operation to NBG for \$5.3M. Seven years after Glenn formed Fisher Entertainment for the purpose of syndicating the Fox Kids Countdown, he's



selling the company and its stable of nine shows to Portland, OR-based N B G.

(Gienn Fisher & NBG President/CEO John Holmes) N B G . Fisher, who describes himself as "a fiercely competitive individualist," says consolidation made it just too tough to run an independent network. NBG picks up these shows: Al Bandiero's Jammin' Party, Ed Tyll, John & Jeff, Liz Wilde, Beyond the Beltway, Bo Reynolds, The Wake Up Show, and Victory — a weekend Christian music program. NBG also nabs Fisher's morning prep service, Wireless Flash. Clear Channel starts to pull away more business from Westwood's Metro and Shadow services. It's just happened in Chicago, where CC-owned Premiere and Traffic.com will handle the content for traffic reports, plus some news, weather and sports. That means Clear Channel repatriates all those 10" avails from Mel Karmazin's troops.



Goodbye, Dallas. Lia wins, and Dallas signs off, as Jones decides that two nighttime country shows is too many, so it's dropping "Dallas Live From Nashville." After

folding in Broadcast Programming, Jones wound up syndicating two competing Nashville-based country music-andinterview shows. It had both Dallas Turner's show and Lia Knight's show. Edie Hilliard says it's time to concentrate on just one effort, and Lia is the winner.



Jones says Lia currently airs on 135 stations and reaches 1.7 million listeners a week. Dallas continues as host of GAC's "Country Request Live" cable show after her radio show winds down in August.

The Grand Ole Opry won't, but Jones will. Syndicate a Saturday evening longform country show, that is. No matter who has owned WSM, Nashville (650), they've jealously guarded the exclusivity of the radio show, and refused to syndicate it. Seems odd, when you can see part of the Opry on cable TV, but current owner Gaylord won't put the Opry up on the satellite for radio. Now Jones reveals that it's offering a 7pm to midnight "Classic Country Weekend" show for Saturday nights, anchored - ironically enough ---- by WSM morning personality Bill Cody. Bill will also host a new daily classic country video show on its Jonesowned GAC (Great American Country) cable network.

Radio newsrooms are becoming less diverse, not more. They're almost 90% Caucasian now, compared to 85.3% in 1994. Radio looks especially bad compared to TV newsrooms, in both onair and behind-the-scenes jobs: Minorities hold nearly 25% of all TV news jobs. For radio, there's been a small drop in the number of African-Americans since 1994 — 5.7% then, 5.2% now. But a very noticeable decline among Hispanics ----7.5% in 1994, just 5.5% now. There's a brand-new study from the RTNDA and Ball State University, and we bet a copy lands on the desk of FCC Chairman Michael Powell - who's already vowed to push for new EEO requirements. There has been progress: 37.4% of radio news staffers are women, an all-time high. Check "RTNDA.org/Research" for more — including the relationship of market size to diversity.

TRANSACTION BRIEF

The following items are based on recent, noteworthy ownership-transfer applications filed with the FCC. The information is based on FCC contracts filed with the Commission and made public within the last few weeks. Market and revenue information is based on data culled from Duncan's American Radio and from M Street's own databases. The transactions are arranged in descending order of sales price. When known, broker notices are included.

Riverside, CA

Entravision sells KCAL, Redlands, CA (1410) to Spanish-language specialist Lazer Broadcasting. That makes II California stations for Alfredo Plascencia's Lazer Broadcasting, which already has Riverside-San Bernardino properties like simulcast regional Mexican FMs KXSB and KXRS. KCAL-AM operates with S-kw day, 4-kw night, DA-N. And M Street notes that rocker KCAL-FM, Redlands isn't affected by this sale. Entravision's selling KCAL-AM to Lazer for \$2.35M.

San Jose, CA

Carlos Duharte has been LMAing KZSF at 1370, and now he's buying it for \$5M. Z-Spanish Trust-owned KZSF at 1370 is actually on its second trustee, as Mark Inglis took over for Charles Giddens. Duharte's paying \$IM in cash at closing, and another \$4M in an 8% promissory note. KZSF is doing regional Mexican during Duharte's LMA.

Anderson-Muncie, IN

Sabrecom (Paul Rothfuss and Joel Hartstone) pays \$8M for five stations from Capital City Radio Partners. Sabrecom's already invested in the unrated market with sports WXFN and hot AC WLBC-FM. Here are the two regional simulcasts (all class A FMs) and the AM that Sabrecom is acquiring: the "Max" classic hits simulcast of WHTI, Alexandria at 96.7 and WHTY, Hartford City at 93. The oldies simulcast of WERK, Muncie at 104.9 and WURK, Elwood at 101.7. And talk/sports WHBU, Anderson at 1240 (700-w fulltime, ND). Seller is Indiana Radio Partners — M Street group "Capitol City Radio Partners." Principals are former Wilks-Schwartz partner Mike Schwartz, former ABC Radio president Aaron Daniels, Monte Lang, Ed Argow, Abe Moses and Bill Burns. Broker: Mike Bergner.

Lexington, KY

No, Cumulus isn't buying WLXO, Stamping Ground (96.1) – Clarity Communications is. The just-filed sale of oldies WLXO to Clarity Communications — not Cumulus — ties up a loose end from a situation involving Blue Chip and Lynn Martin. Martin originally planned to buy both of Blue Chip's Lexington-market FMs: urban WBTF, Midway (107.9) and oldies WLXO. Then, Martin got a chance to buy WSTL, Carlisle, KY from Jack Mortenson, and WSTL's a stronger technical facility than class A WLXO. So Martin's buying Blue Chip's WBTF, but passing on WLXO. From some FCC filings, it appeared Cumulus might have been in the picture for WLXO.

Las Cruces, NM

A five-way legal battle ends as Richardson buys two FMs from Sierra. Among the conflicting claims: Robert May's assertion that he had a valid right of first refusal on the stations that Richardson Commercial offered to buy in 1999. Meanwhile Sierra LMA'd them out to another party, Sunrise Broadcasting. Then Robert May wanted to assign his rights to Matthew Runnels. Among the settlement terms, Sunrise will pay Runnels \$150,000 plus \$2,000 a month for 25 months. At the end of the day, Sierra Industries files to sell the Richardson group CHR KHQT, Las Cruces at 103.1 (the former KXDA) and AC "Vista" KKVS, Truth or **Consequences** at 98.7 (the former KSNM-FM). There's enough ownership overlap between Richardson and Sunrise (which has KSNM at 570 and country KGRT-FM) to require an ownership study for the FCC filing.

Elmira-Corning, NY

For \$2.2M, Robert Eolin converts his LMA of WENY-AM/FM to a purchase. Eolin owns four other stations in Elmira-Corning, NY, and he put WENY (1230) and WENY-FM (92.7) into simulcasts with his own cluster when he began the LMA last Fall. Now he's filed to buy the combo. Eolin Broadcasting has talk WCLI (simulcast on WENY), AC "Crystal" WCBA-FM (simulcast on WENY-FM), plus standards WCBA and oldies "Gem" WGMM. The WENY combo's being sold by White Broadcasting, related to the local WENY-TV. Broker was Elmira's own Dick Kozacko.

Bloomsburg, PA

Veteran programmer Bobby Hatfield buys WCNR (930) from the Press Enterprise newspaper. One of his jobs is to get it back on the air: Press Enterprise took it dark in April. The facility has 1000-w day, 23 night, non-directional, and had been doing talk and sports. Press Enterprise made news when the FCC waived the newspaper-cross-ownership ban in 1999 to allow it to buy WCNR. Now it's selling to Hatfield, former PD at stations like KOMA, Oklahoma City, WTVN, Columbus, WIBC, Indianapolis and WTAM, Cleveland. He's now PD at oldies WBBF-AM/ FM in Rochester.

Dallas, TX

Big money In Big D, as non-com KVTT at 91.7 and its real estate sell for \$22M to a new non-profit group led by Jim Hilliard. Real estate – and precious tower space — are what this is all about, even though KVTT is a full-bore Class C. The actual KVTT license goes for \$5M and the real estate for \$17M. Current group head and former Dallas programmer Jim Hilliard is doing this deal through the Texas non-profit "Learning Foundation, Inc." Seller is the Research Educational Foundation, which retains the Christian rock "Power FM" simulcast of KMQX, Springtown (89.1) and KTPW, Sanger (89.7).

Cheyenne and Laramie, WY

The Brandons' American General Media has inked a \$5.35M deal for a pair of big-signal FMs in Cheyenne and Laramie. AGM gets oldies KRRR, Laramie, a C2 with 50-kw at 99.9, plus classic rock KRQU, Cheyenne, a full class C with 100-kw at 102.9. The seller is Vic Michaels' Mountain States Radio. Michaels put KRRR on the air from a CP last April, and he bought KRQU and "Cool 1210" KLDI for a mere \$875,000 last August. Broker: Star Media Group's Doug Ferber.


"After looking at several options, we decided on the VADIS platform and DC consoles from KLOTZ," says John Decker, Chief Engineer, Capstar Communications, Tucson. "Why? First, our Install would be much faster since most of the plant wiring could be reduced to a simple Ethernet line and a fiber optic cable connecting each room with our rack room.

"Secondly, all four stations were to be housed in the same facility, and we had to share audio sources all around the plant. This is a function that is part of the KLOTZ system. Our entire plant is now based on a digital audio 'backbone' that provides an improved audio signal.

They can put any source in our plant on any fader of the console with a simple LCD button in the meter bridge. Radio is facing new competitors with very deep pockets

XM is ready to blast its way into America's consumer consciousness with a \$100M marketing campaign that hits on August 10 with 60" spots playing on 18,000 movie theater screens nationwide. Rival Sirius Satellite Radio has a warchest just as big.

And now "Radio@AOL" is going to offer 50 channels of "radio" as part of AOL's new 7.0 software – which puts the incessant promotional punch of AOL behind its branded music channels. The first generation of online radio operators has thinned out because of the economics of online advertising – but AOL Time Warner has plenty of incentive to stay in it for the long haul. Some folks even think AOL Time Warner might wind up buying a major radio group. (Bob Pittman knows his way around a radio station.) As the RAB's Gary Fries keeps saying: Now is the time for radio to be as good as it possibly can get – and be a strong local brand.

The new sheriff doesn't like consolidation

It's not "High Noon" yet – but Democratic Senator Fritz Hollings is rarin' to change some of the "lax" policymaking he sees at the FCC, and newspaper-broadcast crossownership may be the first issue he makes an example of. Both the NAB and the newspaper publishers strongly favor ending the current prohibition. But Hollings has introduced a bill that would require an 18-month delay on any FCC effort to relax cross-ownership. Even that's not all: Hollings' S. 1189 would even require the Commission to conduct an immediate review of all previously-granted waivers of the newspaper-broadcast rule, whether temporary or permanent. Gannett and Disney/ABC are among the groups who have already won such waivers. Hollings says ownership consolidation in the media threatens to wipe out the "critically important, independent voices" the country needs. Sounds like former FCC Chairman Bill Kennard, doesn't it? It's a story we'll be following for you – and another example of how the Democratic takeover of the Senate changes the plans of President Bush and FCC Chairman Michael Powell.

Who owns that billboard? Probably a radio company

About two-thirds of America's 400,000 or so billboards are now controlled by companies that also own radio stations. That billboard that you just spent the industryaverage 2.7 seconds reading could be owned by Infinity Outdoor, or Clear Channel (look for the "Eller Media" name), or Ackerley ("AK Media"), or NextMedia (which just bought PNE Media), or some other company with a strategy of combining radio and outdoor assets. Viacom's Mel Karmazin and Clear Channel's Lowry Mays have aggressively pushed the "out-of-home" strategy of radio plus outdoor. And so far, outdoor has weathered the 2001 ad slowdown better than radio: The Outdoor Advertising Association of America says QI outdoor expenditures grew 2%, to \$1.25 billion. Outdoor is a much smaller industry than radio, dollar-wise, but it's a major part of groups like Infinity: Outdoor now generates about 45% of Infinity's revenues. Not surprisingly, M Street notes that Arbitron is pushing into servicing the outdoor industry. It's just hired Jacqueline Noel as Director of Sales and Marketing for Arbitron Outdoor, reporting to senior exec Pierre Bouvard. Noel tells M Street "We're very much in contact now with outdoor companies and agencies - to see what the industry wants." So the People Meter (which has potential to measure TV and cable) and Webcast Ratings aren't Arbitron's only push into new business areas.



WASHINGTON THIS WEEK

More LPFMs than expected? At least 3250 LPFM applications have been filed, and as many as 1200 could become licensed. One LPFM supporter predicts that when all is said and done, 1,200 microstations will be on the air significantly more than Congress expected when it passed the Radio Broadcasting Preservation Act last December. One other thing to consider: Under the amendment signed into law by President Clinton last December, the FCC is required to study the economic impact that LPFM stations have on full-power commercial stations. So along with the results of technical testing, Congress may have a lot more data to look at if the battle over LPFM comes to the Hill again. By the way: those nine test markets for third-adjacent-channel protection tests still haven't been announced yet.

The FCC grants Low Power FMs in Minnesota, Virginia, Wyoming and Michigan. Minnesota gets two: a new 98.5 in Alexandria, MN, licensed to Caravan Broadcasting, and a 96.9 in Hope, MN, licensed to the Hope Presbyterian Church. In Williamsburg, VA, there's a new IO2.5 licensed to the Christian Life Center. In Douglas, WY, the Douglas Baptist Church gets a grant for IO5.1. And in Manistee, MI, the Manistee United Methodist Church gets an LPFM at IO4.3. Meanwhile, the FCC dismisses an app for an LPFM in Bakersfield at 92.9, filed by the Universal Church.

Is the FCC Mass Media staff bogged down by Low Power FM? Privately, that's what some broadcasters and attorneys are saying – that the legacy of Kennard's LPFM plan is burdening the staff with LPFM work on top of the normal workload. The good news, say some: So far, the Michael Powell FCC seems to be cranking out grants of transfer apps methodically and in a timely fashion. That's the first thing lawyers want to see from the Commission: predictability and consistency. Ratings trouble in Havana? Bush nominates Salvador Lew to run Radio/TV Marti, to succeed Clinton appointce Herminio San Roman. It's a plum job for Bush to fill — especially since the \$133,000 a year director's job doesn't require Senate confirmation. The Miami Herald reports the White House choice of Salvador Lew — who will have to give up his talk show on a Miami radio station after 16 years. Lew says he'll produce more relevant programming on Radio Marti, and he charges that Radio Marti's ratings - as best as can be measured by the U.S. Interests Section in Havana - have declined from 70% of the Cuban audience to a paltry 6-7% today. The Cuban-born Salvador and Fidel Castro were classmates at the University of Havana.

Here's the new Senate Communications Subcommittee, now chaired by Democratic Sen. Daniel inouye in the reorganized Senate. It's one of the major "standing subcommittees", and it's a powerful one. Here's the rest of the Subcommittee: Democrats are Hollings (from SC, also Chairman of the Commerce Committee). Kerry (MA), Breaux (LA), Rockefeller (WV), Dorgan (ND), Wyden (OR), Cleland (GA), Boxer (CA), Edwards (NC), and Carnahan (MO). Montana Republican Conrad Burns is the ranking Republican. Other Republicans are Stevens (AK), Lott (MS), Hutchison (TX), Snowe (ME), Brownback (KS), Smith (OR), Fitzgerald (IL), Ensign (NV) and Allen (VA).

Mel Karmazin uses XM and Sirius as reasons to plead for more de-regulation of radio. The Viacom COO tells a Senate Commerce Committee hearing that radio needs further ownership deregulation to compete with the new satellite radio services. He also argued – again — for elimination of the 26-year-old newspaper-broadcast cross-ownership ban, and the 35% national audience cap for TV. Viacom won a reprieve from the FCC's 35% TV rule from the D.C. District Court of Appeals. But it's the reason Karmazin and Sumner Redstone pulled Viacom out of the NAB.

THE TAYLOR REPORT

Arbitron's People Meter works – or at least, it seems to track the Arbitron diary. There were some differences between the two methods, as Arbitron reveals initial results from its field trial in Wilmington, DE: #1, Morning drive listening was lower in the PPM ratings than in the sameperiod diary-measured results for the Spring 2001 book. #2, Late-night listening is higher in PPM. #3, Weekend listening is higher in PPM. #4. The PPM shows an increase in average daily cumulative audience: 75.9% for the PPM versus 66% for the diary. #5, But less listening per day: 2 hours 12 minutes for the PPM, 2 hours 30 minutes for the diary. #6, Outside of radio: Arbitron's PPM brings good news to TV and cable, in the form of higher total-day average quarter-hour audiences. Also higher "combined media" levels. The Arbitron's pager-size People Meter will be worn by "panel members" for at least a year, and possibly two. Arbitron says so far, cooperation and usage by meter-wearers has been good. Details at "Arbitron.com."

It's not just Clear Channel: Citadel is without a contract in many markets. The M Street Daily fax reported that some Citadel contracts have expired, and that same morning. Arbitron President Steve Morris confirmed the situation to analysts in his Q2 conference call. Unlike the Clear Channel standoff, Citadel's disagreement with Arbitron is apparently centering just on money. Not the "national database" or "regional aggregation" issue that Clear Channel has made front and center. (Get daily radio news headlines at "www.mstreet.net")

Arbitron's response rates drop to a new low, and the Advisory Council passes its third straight resolution of concern. The Council wants a specific action plan to improve response rates and proportionality — with deadlines. The "response rate" is a percentage of in-tab diaries (the ones used in a survey) compared to the Estimated Persons in Usable Households from the survey. "Proportionality" measures how well any piece of research does in reflecting the overall makeup of the population. Arbitron's already doing "response rate progress conference calls" with a Council task force, every month. Small market "wobbles" trigger the Arbitron Advisory Council's third resolution - and possibly a new level of sample size. The best

prescription for wobbles in the ratings is to increase the sample size — and some surprisingly big markets have never voted to accept Arbitron's offer of a 40% larger sample size. The Council recommends that "all remaining markets avail themselves" of that option. The Advisory Council also suggests that Arbitron introduce "at least one additional level in the sample size options plan."

Is Rush Limbaugh worth as much as baseball superstar Alex Rodriguez? Premiere says "Yes." Rush and "A-Rod" are getting very similar All-Galaxy deals, worth more than a quarter of a billion dollars over the life of the contract. Premiere won't confirm the numbers first circulated by Matt Drudge (Premiere just says it's a "nine-figure deal, the highest-priced distribution deal in the history of radio syndication"). But Drudge hears Rush gets a \$35M signing bonus, plus \$250M over the next 8 years. Is he worth it to Premiere – and to Clear Channel, which uses Rush on many of its stations, and also enjoys revenue from nonowned stations? We'd have to answer "yes." Rush has been in syndication now for 13 years, and Premiere's Kraig Kitchin says advertiser and affiliate demand are at an all-time high.

Las Vegas-based Talk America will consolidate its two 24-hour talk networks into one. Paul Lyle says the current "Talk I" and "Talk 2" configuration "makes no sense — we're competing with ourselves." Paul's got the unenviable task of whittling down a roster of over 60 talkshows to about half that. The goal: "Pick the shows with the greatest long-term potential for revenue and ratings." Las Vegas-based Talk America recently scored a big brand name when it became the new home of Bruce Williams, recently departed from Westwood.

MediaPassage suspends its broadcast operations and will "re-tool." That's the Seattle-based ecommerce solutions company that merged with Chicago-based BroadcastSpots.com last year. MediaPassage has plenty of weight in the print field, providing planning, placement and payment of advertising buys in newspapers. But it admits "the company is not currently as technologically sophisticated in broadcast as it is in print." And suspends broadcast operations while it does further R&D. President Richard Warren vows to re-enter the broadcast field.

Don & Mike move to middays, as the Infinity push for Opie & Anthony expands. Don & Mike (based at D.C.-market WJFK-FM at 106.7) are killers in afternoon drive - but their syndication prospects were blocked by the emergence of Opie & Anthony in the same timeslot, working for the same syndicator. Now Don & Mike do the smart thing by shifting to middays on WJFK-FM, and probably set themselves up to finally get cleared live in New York on talker WNEW (102.7). We'd expect Infinity and syndicator Westwood to offer them as a I-2 punch elsewhere: Don & Mike, followed by the exploding Opie and Anthony. There's one casualty in Washington: "G Man" G. Gordon Liddy, who loses his Ilam-2pm roster spot at WJFK-FM to Don & Mike. He had solid numbers, but his politically-oriented show doesn't fit Infinity's "guy talk" direction on WJFK.

New software to slice and dice the numbers, as former Tapscan Worldwide exec John Barlett and Drew Simpson launch "AirWare RSS." It's a new ratings analysis and sales presentation program, designed for salespeople — and it even speaks multiple languages (there's a Spanish-language version coming soon). AirWare RSS is already working in Canada and Australia, and now they're offering the package in the U.S., now that they've secured a thirdparty processor agreement with Arbitron. Details from John Barlett at (S6I) 798-5592 and "http://airwarerss.20m.com."

Surgery silences ABC's Paul Harvey for now. Paul will undergo surgery at the Mayo Clinic in Rochester, MN, to repair a weakened vocal cord. A severe case of laryngitis has kept Paul off the air since May. The 82-year old radio legend signed a new IO-year, \$100 million contract with ABC last November. Not only do listeners miss Harvey's confident voice – ABC has to be thinking about the "what if" scenario of how Harvey's pipes will sound, postsurgery. And we bet Paul is a wee bit anxious about the results, too – we hope he returns soon, literally good as new.

The following items are based on recent, noteworthy ownership-transfer applications filed with the FCC. The information is based on FCC contracts filed with the Commission and made public within the last few weeks. Market and revenue information is based on data culled from Duncan's American Radio and from M Street's own databases. The transactions are arranged in descending order of sales price. When known, broker notices are included.

Riverside-San Bernardino, CA

Salem improves its situation in Riverside by selling KEZY (1240) and buying Entravision's low-end-of-the-dial KSZZ (590). It's selling the 1240 to Salem director Roland Hinz — who did something similar last year when he acquired L.A.-market KLTX from Salem. KEZY is now doing Christian programming as "K-Lite", and Hinz is buying it for \$4M for his "Hi-Favor Broadcasting." Meanwhile Salem's acquiring stronger-signalled KSZZ from Entravision for \$7M, less \$60,000 as a credit to cover painting the three towers. KSZZ is now doing regional Mexican, but look for that to change under Salem.

Tallahassee, FL

Cumulus sells R&B oldies WWLD (106.1) to David Benjamin's Triad Broadcasting for \$1,725,000. This station used to be a CHR that competed with a station Triad now owns: "Hot 104.9" WHTF. Now WWLD is doing R&B oldies and Triad is tucking it into its Tallahassee cluster. It also becomes a sister to Triad's country "B103" WAIB and rocker WYZR. The remaining Cumulus cluster is formidable, including urban "Jamz" WHBX.

West Palm Beach, FL

For \$20M, Infinity adds WJBW, Jupiter (99.5) to Its cluster – and attracts an FCC red flag for a station that's about to move up the dial. Looks like Mel Karmazin was able to finally convince Laurie Silvers and Mitchell Rubenstein to sell WJBW. The 6-kw class A licensed to Jupiter, FL, operates at 99.5, but FM Radio Acquisitions has a CP to upgrade it to a full C at 106.3. The adult standards FM will be Infinity's fifth in the market, adding on to the cluster that includes country WIRK.

Baltimore, MD

WJHU host Marc Steiner wins the bidding for Baltimore non-com WJHU-FM (88.!) — and gets management help from AGM's Tony Brandon. Johns Hopkins has signed a letter of intent with the "Maryland Public Radio" group led by Steiner, reports the Baltimore Sun. And American General Media exec and Baltimore resident Tony Brandon will help with management. Expect a call letter change from the Johns Hopkins-associated "WJHU." School budget officer Frederick Puddester says it could've gotten more money from a religious broadcaster. But it wanted to keep WJHU doing news and information. It also plays classical and jazz outside of drivetimes.

Northern Michigan

Roy Henderson strikes again, buying the CP for a new Class A FM at 104.1 MHz licensed to Pinconning, MI. Seller is Russell James Lafave, who's based in Midland, MI. Henderson's Fort Bend Broadcasting will add the 104.1 to other recently-acquired Michigan stations such as AC WLDR, Traverse City (101.9) and WBNZ, Frankfort (99.3). Henderson will pay \$250,000 for the Pinconning CP. Broker: Hadden and Associates.

Northwest of Las Vegas

Todd Robinson buys the CP for a new FM at 101.1, now called KPUP. KPUP is being sold by James R. Marsh, filing as Amargosa Valley Broadcasters. Robinson is working his end of the deal through Argosa Broadcasting. Price for the CP: \$350,000. KPUP's current papers are for a Class A — but there's an app for an upgrade to a CI.

New Jersey

For \$13M, Millennium's Charlie Banta has the option to buy yet another FM from Nassau. It's the CP for a new Class B at 105.7 licensed to Manahawkin, in Ocean County. That would give Banta's Millennium even more firepower at the Jersey Shore, though this CP has had a troubled history. And Nassau doesn't own it yet: It's holding an option to purchase the stock of Manahawkin Communications Corp. Millennium is paying Nassau \$1M — non-refundable — to nail down an option for the 105.7. Once the FCC approves Nassau's pickup of the CP, Millennium has 12 months to exercise its option and to pay Nassau \$12M more.


Wilmington-Philadelphia area

Catholic Radio Network sells Philly-area WPWA (1590) to the Rev. Sun Young Joo's Mount Ocean Media, for \$675,000. The Reverend Sun (of the Assemblies of God) founded the non-com Hanguk Christian Broadcasting and is now involved in the northwestern New Jersey WMBC-TV. We can't tell what the Rev. Sun and partner Joon S. Joo plan to do with WPWA — but we're certain that Catholic Radio Network is delighted to find a buyer. WPWA, Chester, PA has 2500w day, 1000-w night, DA-N.
