Have radio stunts gone over the line?

Opie & Anthony's graphic play-byplay of a gay man having oral sex with a woman in order to win 'N Snyc concert tickets was featured on ABC-TV's "20/20 Downtown" – and so was Mancow Muller's confession that he has trouble sleeping because he's trying to push the envelope with far-out stunts. Public opinion does matter – and mostly, the public gives shows like Opie & Anthony. Mancow and Howard Stern high ratings. But watch the new FCC: Both Commissioners Kevin Martin (Republican) and Copps (Democrat) have already said they're willing to get into content regulation when it comes to indecency. The FCC has recently stayed away from regulating content, except for blatant cases of indecency. But the combination of pressure from the right and the left may produce a coalition that's willing to get much more aggressive. After talking with policymakers and observers at the NAB Radio Show, we can tell you that the FCC may just poke its nose under the tent for the first time in many years. There could be a cultural showdown coming – even if FCC Chairman Powell doesn't want it.

Is DAB ready for the big push to the goal line?

You're going to be seeing lots of activity on the IBOC (in-band on-channel) front,

as development consortium iBiouity will formally ask the FCC to move on the



issue - at least toward an FM standard.

One question is whether the Commission should make iBiquity a "mandated standard." A bigger question is whether radio operators who are enduring their worst advertising year since 1990-91 will be willing to make the huge commitment in capital. IBiquity expects to make the 2002 Las Vegas show the launching pad for Digital Audio Broadcasting. But how fast will DAB take off?

NAB Radio Show 2001 had new products, new vendors, but no Clear Channel and no Infinity

The Big Two were conspicuously absent from New Orleans, thanks to #I. Clear

Channel holding its own managers meetings in



Atlanta at the same time. And #2, Infinity's forced absence because of Viacom's pullout from the NAB over TV-ownership disputes. Neither group had many representatives last year in San Francisco, but this year the pullout

was near-total. The truth is that the NAB still makes money on the Radio Show – though nothing like the bonanza it reaps from the Spring show in Las Vegas. As for the conference sessions, this year the NAB eliminated the programming format rooms entirely – a silent acknowledgement that many PDs just aren't coming to the onetime "Radio Programming Conference." The NAB hopes that returning the Radio Show to Seattle in

2002 piques more radio interest, especially since the September II-I3 date won't be adjacent to Labor Day. One of the stars of the NAB Radio Show THIS year: New Orleans. The city looks cleaned-up and ready for prime time, compared to the NAB's last visit to the Big Easy in 1997. It's got more hotel rooms near the convention center, a funky and fun Warehouse/ Arts District – and the yummiest collection of restaurants this side of paradise.

Ninth Edition (10th edition coming in July 2001) for \$65.00 (plus \$7 \$&H). It's a four-person FCC for at least the rest of the year. That's thanks to the September 7 departure of Democratic gadfly Gloria Tristani, who's hoping she has a roundtrip ticket back to Washington from her home state of New Mexico. She's leaving her term early to pursue her political ambitions, and that leaves newcomer Michael Copps as the lone Democrat on

the Commission. Chairman Michael Powell now has a 3-I working majority and should have no trouble getting his policy initiatives through the Commission. M Street expects the 3-I situation to continue for quite a while: Tristani's replacement will need a background check, then actual nomination, Senate committee hearings, followed by a Senate vote. The second Democratic seat could remain empty well into the Fall of 2001.

Bush gets to select a Democrat to replace Tristani — but he's got bad timing. If Tristani had split while the Republicans still controlled the Senate, the choice and confirmation process would've been a lot easier for Bush. Now Bush has to please the Democratic leaders of the Senate instead of Republican Trent Lott. The front-runner to replace Tristani may be Andy Levin, an aide to House Democrat John Dingell. Other names in the rumor mill: Former Clinton NTIA chief Greg Rohde. Former Gore advisor Kathleen Wallman. And AT&T lobbyist David Krone. But Bush could go with a conservative Democrat and risk a bumpy confirmation fight in the Senate.

LPFM update: Petitions to deny from the January filing window are due by September 17. The FCC has "accepted for filing" Low Power FM apps in these states, from the filing window that was open January I6-22, 2001: CO, DE, HI, ID, MO, NY, OH, SC, SD and WI. The August 16 Report (LPFM-S-2) also includes "accepted for filing" apps from previous filing windows — so even if you're not operating in one of the states we printed above, it's worth glancing at the list.

AM Auction #32 hangs in limbo. The only thing that's happened recently on this front is the Commission's addition of the Mike Rice AMs (such as WBOW. Terre Haute at 640) to the lineup of frequencies to be auctioned. But the last scheduled event was on July 24, when the short-form (Form 175) apps were due. Now — everybody's figuratively standing in the lobby of the auction house, waiting around. The FCC has yet to announce dates for upfront payments or the mock auction — much less the auction itself. The lack of hard dates has some applicants wondering what's going on. Meanwhile, the next FM Auction — the already-postponed Auction #37 — does have hard-and-fast dates, such as the

September 24 deadline for submission of Form 175 apps and the December 5 auction itself. But the Commission has yet to announce how it will finesse the roadblock thrown up by the D.C. Circuit Court of Appeals on the question of non-profits participating in an auction of commercial-band frequencies.

Alaska's Peninsula Communications faces \$140,000 in fines for operating its seven FM translators. Peninsula defied the shutdown order and has continued broadcasting on facilities like K28SEF, Kenai, AK. (You know you're in trouble with the Commission when the Notice says "Former Licensee.") The FCC's original order in May was triggered by violations of the rule about re-transmitting signals from outside the area. But Peninsula didn't shut down, and now it faces \$140,000 in fines and perhaps an even harsher sanction: potential revocation of other licenses it still holds. Meanwhile Peninsula is talking to the local newspaper about another delay, in the form of an expected appeal to the D.C. Circuit Court of Appeals.

Merging the FCC's Mass Media Bureau into a new super-bureau would require approval of Congress. For one thing, the Bureau wouldn't disappear, but would be "merged" into the new division. For another thing, any structural change that big would certainly require a Notice and plenty of opportunity for public comment. And — it would reportedly require a stamp of approval from Congress. Making the Mass Media Bureau go away is something that's making some folks inside the Commission very antsy. But is it something Chairman Powell is investigating? The FCC had already begun its hard look at re-structuring and streamlining under previous Chairman Kennard. The Commission's last major revamp of bureaus affecting broadcasting was in 1982.

The NAB's getting tough with satellite radio.

The association's blasting away on several fronts, just as XM Satellite Radio looks at its September 12 consumer launch in Dallas-Ft. Worth and San Diego. One NAB argument is that XM and Sirius are changing the rules of the game by requesting up to 1,000 terrestrial repeater stations - as many as 66 in the Boston area alone. Hilly San Francisco is one thing, the NAB says. But Boston shouldn't require that kind of penetration for repeaters. The NAB's core concern is local origination. Its filing at the FCC notes that the new "SDARS proposed rule does not preclude locallyoriginated material." Broadcasters have long suspected that repeaters could be employed to plug in local advertising — thus making satellite radio a true competitor for the 80% of radio's revenue that comes from local-market advertising.

THE TAYLOR REPORT

A Bill Clinton radio show?

No – but the story got batted around in the national media like a beach ball after Matt Drudge picked up the M Street Daily story about a syndicator quietly sounding out key stations about a Bill Clinton short-form show. We're 100% sure that actually happened. But



we carefully never said that the former President himself was on board for the deal. At least Matt Drudge understood what we said. But many other news sources quickly turned our story into another chance to put Clinton in the headlines.

Clinton's own people then denied that he has a radio deal – which we believe is 100% correct, as of now. A source familiar with Clinton's thinking speculates this way: After Clinton defeated George Bush, Sr. in '92, Bush refrained from criticizing Clinton's rocky first year in office. Now ex-President Clinton's in the same situation — and he'll refrain from daily partisan potshots. Of course he may feel differently next year, and we bet the syndicator will still be there.

Clear Channel's KIIS-FM, WSIX, WLTW and KHMX will be "superstations" on the XM lineup that debuts September 12.

MediaWeek reports that Clear Channel which has invested \$75M in XM Satellite Radio — gets the privilege of being the only program producer to place local outlets on the XM lineup. That means the development of potential "super-brands" – and another reason for Clear Channel to enforce its claimed national copyright on "Kiss." The four new satellite "superstations" are CHR KIIS-FM, Los Angeles, country WSIX-FM, Nashville, soft AC WLTW, New York and hot AC KHMX, Houston.

ABC signs WABC-based Sean Hannity to a major syndication deal, both inside and outside ABC.

Much like Infinity's determination to quickly place Opie & Anthony in major markets, ABC has marched ahead and cleared conservative talker Hannity in markets like Los Angeles (on KABC) and Washington (on WMAL, taking some time away from veteran afternoon driver

Chris Core). ABC's John McConnell says "We've never seen a prime-time show clear in this many major markets right out of the gate" – we'd say partly because ABC is pushing the show hard. One theory is that ABC wants some protection in case Premiere starts pulling Rush Limbaugh off of the big ABC O&Os.

The industry's finally ready to work on EDI – Electronic Invoicing.

The rap on radio from agencies and big advertisers has always been that "it's too hard to buy", compared to TV and other media. EDI could go a long way handling that objection. The RAB says a new task force is working on the issues of standards and technical issues, and it comprises reps from ABC, Bonneville, Clear Channel, Cox, Cromwell, Cumulus, Emmis, Entercom, Greater Media, Hispanic, Infinity, Radio One and Susquehanna, plus Katz, Interep and Westwood. The RAB's Mary Bennett and Entercom's Steve Fisher are chairing an all-star ED1 Task Force. Meanwhile, Westwood's Joel Hollander says Westwood is the first radio network to offer EI to all agencies that accept industry-standard invoices — effective immediately.

Newest kid on the block is group owner Mapleton Communications, built with funds from a cashout from Falcon Cable. California-based Mapleton has announced deals to acquire stations in Medford-Ashland, OR (from Marathon Media) and down in Merced, CA (in two separate transactions). We're expecting Mapleton to strike in at least one other California market. Broker Elliot Evers has been working with Mapleton and its rumored \$100 million warchest.

R.I.P., Austin-based broker Norman Fischer, a genuinely nice guy. Norm passes away after 27 years in the brokerage business. He'd been undergoing treatment for cancer, and died at his



home at the age of 77. He's survived by his wife Cecile, and by his son Terrill, who will continue operating the brokerage company. Norman started his business in 1974 and eventually brought Terrill into it. The family's asking that in lieu of flowers, contributions be made to SafePlace, Attn: Development Dept., P.O. Box 19454, Austin, TX 78760. Nice guys don't have to finish last, and Norman proved it.

LAFAYETTE, LA:

Regent pays nearly \$40M to roll into market #253. \$17.3M was the market's total radio revenue last year, according to Duncan's American Radio, so Regent is literally shelling out double the total revenue to acquire the major cluster built up by Tom Galloway's Communications Corporation of America. But Regent correctly notes that Lafayette is a much larger revenue market than its population suggests. It ranks way down at #253 in population. But Duncan's makes Lafayette #111 of the 173 markets where it ranked revenues last year. The CommCorp cluster is major-size — AC "Mix 99.3" KTDY, a full class C. Country "Dog" KMDL, Kaplan, LA, a C2 at 97.3. Classic rock "K-Rock" KRKA, Erath, a C1 at 107.9. Modern rocker KFTE, Breaux Bridge, LA, a C3 at 96.5. News/talk KPEL-FM at 105.1, a class C3 licensed to Abbeville. ESPN affiliate KPEL at 1420, 1-kw day, 750-w night, DA-N. And adult standards KROF, Abbeville at 960, a 1-kw daytimer.

MEDFORD-ASHLAND, OR:

Marathon sells its six-station cluster to new entrant Mapleton Communications. Marathon (Chris Devine and Bruce Buzil) is spinning this cluster in Arbitron market #209 two years after it acquired it from Citadel. The stations: sports "Score" KTMT, Ashland, a I-kilowatter at 580. Dance "Beat 93" KTMT-FM, a class C at 93.7 licensed to Medford. News/talk KCMX, Phoenix, OR, a Ikilowatter at 880. Soft AC "Lite IO2" KCMX-FM, a C at IOI.9 licensed to Ashland. "Cat Country" KAKT, a C at IO5.1 licensed to Phoenix. And classic rock KBOY-FM, a CI at 95.7 licensed to Medford. These are Mapleton's first properties, and it's already begun LMAing them.

TEXARKANA, AR/TX:

Exactly two years after getting KMJI, Ashdown, AR (93.3) on the air, Jay Bunyard deals it to Clear Channel for \$1.5M. AC "Magic 93.3" goes into a Clear Channel cluster that includes KKYR-FM (12.6 share in the Spring), CHR "Power 95.9" KPWW (7.9), classic rock "Eagle" KYGL (5.3). Seller Bunyard already has a signed LMA with buyer Clear Channel for the Class C3 FM.

MERCED, CA:

Mapleton's opening deal in Merced is for three stations owned by Ed Hoyt: "Oldies 97.5" KABX-FM, a class B. News/talk KYOS at 1480, with 5-kw fulltime. And "Big IO6" KIBG, an A at IO6.3. They're all licensed to Merced (pronounced "mur SEHD"). Price: \$4.3M. Brokerage credits go to Elliot Evers (for buyer Mapleton) and Patrick Communications' Larry Patrick and Greg Guy (for seller Ed Hoyt). Merced: Mapleton Communications buys the four-station Clarke Broadcasting cluster to add onto the three properties it's buying from Ed Hoyt. The Clarke properties are: Regional Mexican "Radio Lobo" KLOQ-FM at 98.7, a class A licensed to Winton, CA. AC "Q92.5" KJMQ, an A licensed to Atwater. And the ranchero simulcast of KRAN at 1580 and its expanded-band twin at 1660, named KAXW. Mapleton will operate the Clarke stations under an LMA prior to closing. Clarke's principal is veteran owner Randolph Holder, based in Sonora, CA. San Francisco-based Elliot Evers has been working with Mapleton.

BOISE, ID:

Journal buys a TV station to complement its six radio properties in Boise. Journal Broadcast Group acquires ABC affiliate KIVI-TV, Nampa from another outfit with strong newspaper roots: Evening Post Publishing, based in Charleston, SC. Journal became familiar with the Boise market when it acquired the American General Media cluster: adult standards KGEM, AC "Star" KCID-AM/FM, classic rock "JIOS" KJOT, modern rock "The X" KQXR, and adult alternative "River" KRVB. Kalil & Co. brokered the Journal-Evening Post agreement.

LAS VEGAS, NV:

Hispanic buys a stick (a future Class C FM) for \$16M. Mac Tichenor demonstrates yet again that he's playing for the long-term, and is willing to buy a total "stick" and make the necessary investments — if it gets him what he wants. This deal with KPXC owner Claire B. Benezra gives Hispanic Broadcasting its second FM in Las Vegas. The facility is currently well out of town, and it's doing country. That will all change when KPXC, Indian Springs, NV upgrades from a Class A to a full Class C facility at 99.3. HBC's current FM there is regional Mexican KHOT-FM (105.9). Broker on the Benezra-Hispanic deal: Kalil & Company.

ANN ARBOR, MI:

For \$2M, Clear Channel makes talker WAAM (1600) its fifth station in the hometown of Big Blue. Seller is Whitehall Enterprises, run by Lloyd Johnson, and it has owned the standalone AM for many years now. WAAM is a full-time 5-kw facility (DA-2), and it becomes a sister to Clear Channel's country WWWW (102.9) and sports WTKA (1050). The FCC's Mass Media Bureau wasted no time in slapping a "red flag" on this application.

MIAMI-FT. LAUDERDALE, FL:

Miami recently got a new AM at 1020, and now WRHB is being sold to WKAT owner Adib Eden. Mr. Eden does this purchase as "New World Broadcasting", separately from the Spanish Media Broadcasting LLC which controls longtime Spanish-language adult standards-and-talk "Radio Uno" WKAT at 1360. His 5% partner in New World is a very identifiable face in the world of Spanish radio: Herb Levin. WRHB is licensed to Kendall, FL with 9,000-watts day and 980 night, DA-2. This station was known as WRBF, back when it was still a Construction Permit. These days it's on the air and doing ethnic programming for seller Baja Florida Radio. New World is paying Richard Bowers' Baja Florida \$260,000 for WRHB.

Radio has some hard lessons to learn from September II

Some are simple: having a backup antenna is good (ask WKTU, which had one, or WPAT-FM, which didn't). Having an immediatelyavailable source for news and information is good (ask WXRK and WNEW, which simulcast all-news sisters WINS and WCBS). Having at least a news network to go to is good (many stations learned that lesson during the 1990-91 Gulf War). But how about the Emergency Alert System? EAS was not triggered in either New York or Washington and a lively debate has broken out about the purpose of EAS. Would it have done any good in the terror-stricken moments after Flight 11 crashed into the World Trade Center? Or after the American Airlines jet hit the Pentagon? We're all looking for

positive things right now, and M Street suggests that one of them is the opportunity to review your emergencypreparedness plans. Look at the checklist (or make one), and see if you've got enough battery backups, lighting, spare parts, etc. Not to mention checklists of key suppliers and people, with 24-hour phone numbers. Learn some lessons from the September 11 attacks – even if it means spending a couple of bucks you didn't think you could spare.

Cool that auction fever: The FCC's 350-station FM Auction #37 gets shelved

Blame THIS postponement - the second one – on the FCC's inability to cope with the D.C. Circuit Court of Appeals' July 3 decision in the National Public Radio case. But you truly can't blame the Commission: Congress and the courts have jammed it deeply into a hole on this one. Auction #37 was originally scheduled for May 9, but got pushed back to December 5 (news which was announced during that now-infamous March 7 pre-auction meeting in Washington). Now the auction's been put off indefinitely. The crux of the FCC's dilemma is that thanks to the NPR decision, it can't proceed with an auction that has two unequal classes of applicants for the same frequencies. That's because the court says non-commercial educational entities (NCEs) can't be forced to participate in auctions. But Congress instructed the FCC to use auctions for commercial-band allocations. The FCC correctly says that "each of the vacant non-reserved FM allotments included in Auction No. 37 is potentially impacted" by the court ruling – which comports with rumors we've heard that one or more large non-com operators was planning to file apps for each of those 350 allotments. This could be a long wait.

WASHINGTON THIS WEEK

After 19 years, it's so long, Mass Media Bureau. The FCC makes it official at the September 13 meeting: The new super-sized "Media Bureau" will swallow up the Mass Media Bureau. Current Mass Media chief Roy Stewart will be honcho of the new "Office of Broadcast License Policy" inside the superbureau (but no longer carries the status of "bureau chief"). The news – which M Street's been expecting since August — was buried in the "FCC Reform" report submitted to Chairman Powell by Special Counsel Mary Beth Richards. The "Media Bureau" will be run by current Cable Bureau Chief Ken Ferree, and it will have its hands full supervising video news and entertainment policy and licensing, along with EEO, political programming, AM, FM, LPFM, TV, LPTV, cable policy and DBS. It will have a Policy Division, Engineering Division and Industry Analysis Division. The Office of Broadcast License Policy (Stewart's bailiwick) will contain an Audio Division and Video Division.

Amber Plan launches in Washington, D.C. The Post says about a dozen D.C. radio stations and two TV stations (WTTG and WILA) have signed on to the child-abduction-warning plan. It piggybacks onto the existing EAS scheme — though it's activated by law enforcement authorities and is not actually part of EAS. M Street believes the FCC is seriously considering giving the Dallas-originated Amber Plan an "event code" in the next revision of the Emergency Alert System. Dallas-Ft. Worth broadcasters like ABC's Tyler Cox tell us the Amber Alert Plan has demonstrably contributed to the rescue of several abducted children in the Metroplex.

Broadcasters and NAB lost their opening court battle against streaming royalties — and may not appeal. They may be wary of taking another loss further up the line, following their defeat in Philadelphia federal court. Bonneville, Cox, Emmis, Entercom, Infinity and Susquehanna would have to pony up more money for legal bills if they chose to proceed to appellate court — and we've always said this matter would come down to the NAB seeking help from Congress. That's the way it looks to us, following various panels and hallway conversations we had in New Orleans.

Wash your mouth out: The new FCC Commissioners are sensitive to broadcast indecency. And to that end, they might even endorse full-time airchecking by licensees, though so far the conversation about that topic includes the word "voluntary." We'd note that Canada and the U.K. both require licensees to run full-time airchecks, in case there's a complaint from listeners or the government. That's why most American broadcasters DON'T run airchecks, on the theory that if they don't have an aircheck, it can't be used against them. New Commissioners Kevin Martin, Kathleen Abernathy and Michael Copps guested at the NAB Radio Show "Policymakers Breakfast" and it's clear they're interested in beefing up and/or enforcing some policies that broadcasters should pay attention to.

Richmond, VA FM pirate Khalid Kubweza is convicted on four criminal counts. He was one tough customer: Kubweza persistently refused to quit operating at 91.7 MHz despite action by the FCC and the civil courts. Now the Commission says he's been convicted on four separate criminal counts – criminal, not civil — of operating without a license. Kubweza faces sentencing on December 12 and would be liable for up to \$100,000 in fines and a jail term of one year, or both.

The FCC asks the Supreme Court for more time on its EEO appeal. Will the FCC take the dicey option of appealing to the Supreme Court or not? Chairman Powell was facing a mid-September dropdead date for deciding whether to appeal its most recent loss at the D.C. Circuit Court of Appeals. At the last moment the Solicitor General, on behalf of the FCC, asked the Supreme Court for an extension of time to file. On the pro-EEO side, there's concern that if the Supreme Court knocks down the Kennard-era "outreach" rules, that could make things more difficult for other EEO programs. The state associations fought the war to have Kennard's rules declared unconstitutional – and they were victorious, at the appellate level.

Is it finally "goodbye" to the newspaper-broadcast cross-ownership ban?

The FCC just opened the door – wide — to ending the 26-year-old rule. True, the September 13 Notice of Proposed Rulemaking includes a range of options, including possible new standards for "market concentration" or "voice count." But if you read between the lines, Chairman Powell asks for commenters to take into account the roughly 40 exceptions to the rule that have been grandfathered, plus the four that were granted permanent waivers. He seems to be saying that the horse is already out of the barn – and sure enough, one of the options is total elimination of the rule. The newspaper publisher's group practically stood up and cheered, and many broadcasters want to see the 26-year-old rule gone, too. It would introduce a whole new pool of station buyers – the local daily newspaper owners. Still, brokers question whether many newspapers understand broadcasting enough to jump into a totally different business – or whether some current radio/ TV owners would go the other way, and try

to buy a daily newspaper. Public interest groups are already decrying the Notice – even though one of the FCC's ideas is to keep editorial departments separate in newspaper-broadcast combines. Comments are due in 60 days, with reply comments due 30 days after that. Look for opposition from Senator Hollings at the Commerce Committee – but we're expecting an FCC rule change as soon as Christmas.

THE TAYLOR REPORT

It was world-class public service, but September II cost radio millions a day in revenue. Obviously the tragedy is about human lives, not dollars and sense. But we've heard about nervous group heads beginning to tote up how much Q3 and Q4 revenue the terrorist attacks will cost their stations, and it's a very large number. It's startling to realize that some major-market stations - like a midlevel station in Chicago or Detroit - lost \$40,000 to \$50,000 every day that they weren't playing commercials. The ongoing question is – how bad will the cancellation problem be? Some advertisers would like to continue marketing, but they're unsure about what tone to take with listeners. And New York City, ground zero, appears to be a special case - especially hard-hit. There is one new category, though: We heard no fewer than five insurance companies advertising on WCBS and WINS in the space of one hour. Radio's still a superlative way to reach people quickly.

Managers are urgently reevaluating strategies for the Fall book. Should they ice their expensive Fall contesting? Pull billboards that look too frivolous or contest-happy? Freeze plans for expensive direct-mail campaigns? Postpone TV buys until the anguish over the World Trade Center subsides? The New York and Washington tragedies happened to hit just at the opening inning of the Fall Arbitron, which began on Thursday, September 20. Arbitron says that for now, everything's on schedule, though the Arbitron Advisory Council says it won't be surprised if the Summer Arbitron results for some markets are delayed somewhat.

Let's make a deal? Probably not. One of the casualties of a slow economy and an even slower advertising market has been station trading. Heck, we hadn't even heard a halfway decent rumor, until speculation reached us about a possible sale

of Frank Osborn's Aurora Communications. The rumor was that Aurora's backers are ready to cash out, and that they'd recruited Deutsche Banc Alex. Brown to handle the sale. The rest of the rumor is that Aurora could go to a company like Cumulus or Citadel. We called Osborn himself, and he confirmed the part about Alex. Brown being retained. But he tells M Street the process started outside his company: "Several companies approached us. Our basic view is, we'll listen. But we are not, have not been, and will not be marketing the company. If they want to come talk to us, we owe the responsibility to our stockholders to listen." Aurora is based in the affluent New York and Connecticut suburbs outside of New York City, and there's been speculation about its future since last year's aborted merger with Nassau. Will we finally get a sizable deal? Sounds as if it's at least a possibility - and the folks who stoke the rumor mill observe that Osborn's previous group was built and then sold.

New Orleans wasn't a home run – but it wasn't a strikeout. The NAB's postconvention problem is to turn around the perception - mostly among people who weren't at the Radio Show - that it was a bust. The truth is that most exhibitors had lowered their expectations going in --- unlike Orlando in '99, where the turnout was a nasty surprise. This year, the scheduling (near Labor Day), the heat of New Orleans, and the absence of Infinity and Clear Channel all hurt. So did the economy, with T&E budgets being shrunk. And there were fewer exhibitors and fewer attendees. We also noticed fewer events being sponsored, which means less revenue for the NAB. But business was getting done and the quality of the seminars was high --- even if there were no sessions devoted to specific formats. The NAB's challenge, building up for next year in Seattle, is combating the perception that New Orleans was a bust. We thought Marconi Awards hosts Tim & Willy did a fine job at the Friday night awards and they seemed genuinely surprised when they got to accept the Legendary Marconi Awards for their home station, CC's KNIX-FM, Phoenix. Our congrats to all the Marconi nominees and winners - and we hope (like the NAB) that Infinity will be back in the fold in time for next year's Marconis.

The RAB's Gary Fries says "I have to chastise the industry."

He did it in New Orleans, and on not one but two counts: #1, for having a "deer in the headlights" reaction to the current advertising slowdown — doing a lot of finger-pointing and "sitting behind the desk" instead of searching for revenue solutions. And #2, for "giving lip service to sales training", particularly for newly-hired account reps. He says "you can hire all the bodies you want — but bodies don't do it." Training, such as the RAB's Sales Academy, does. Fries claims that 85% of the 560 people who've gone through the Academy are still in radio.



WASHINGTON THIS WEEK

A Trojan horse? Satellite radio operators Sirius and XM get Special Temporary Authority from the FCC to operate terrestrial repeaters. This issue mushroomed into a heated battle, with the NAB trying to make sure that Sirius and XM weren't using terrestrial repeaters as a Trojan horse - a way to get local programming capabilities, or at least local ad-selling possibilities. The Commission did grant STAs to both Sirius and XM, but forbade them from using the repeaters for anything other than straight simulcasting of the satellite signals, as a fill-in around difficult terrain. For Sirius, that authority for "complementary terrestrial repeaters" is for 2320-2332.5 MHz. For XM, it's 2332.5-2345 MHz. STAs for both services expire on March 18, 2002, or whenever the FCC gets around to adopting permanent rules for SDARS (Satellite Digital Audio Radio Service).

Is the FCC holding up deals because of race-based demands? That's what Sinclair says. Ouch: It's bare-knuckles time. Sinclair petitions the D.C. Circuit Court of Appeals to force the Commission to cease what it calls its "bad-faith delay" and approve Sinclair's pending apps to buy IS TV stations. Sinclair alleges that the Commission is trying to force it to handle necessary divestitures from the deals "solely on the basis of race, rather than to the highest bidder." It says the transfers have all been okayed by DOJ and comply with current FCC rules, and the FCC should move the transfer apps promptly. ■

Phoenix, AZ:

Cash-strapped Big City Radio sells its four-station Phoenix cluster to Hispanic for \$34M cash. It's a bitter pill, but Big City really needs the money, with a missed interest payment due back on September 15 (it's scrambling for bridge financing). Phoenix should be a promising market for Spanish-language radio, with its 21% Hispanic population. And Duncan's says Big City billed nearly \$6 million there. But faced with possibly the choice was clear. What is still unclear is whether more stations will have to be sold off to get Big City back on solid ground. Was Infinity also gunning for Big City's Phoenix properties? Here's what Hispanic Broadcasting gets: Modern rock KBZR, a class A at 106.5 licensed to Arizona City. Also, the modern rock simulcast of KDDJ, a C at 100.3 licensed to Globe, and KEDJ, Sun City, a C2 at 106.3. Plus Spanish CHR KSSL, Wickenburg, a C2 at 105.3. HBC says three of the stations will air a Spanish-language format. The fourth will simulcast its current Phoenix station, regional Mexican KHOT-FM.

Grand Rapids, MI:

AM specialist Sima Birach pays \$1.9M for WMJH, Zeeland (8i0) and WMFN, Rockford (640). Detroit-based Birach Broadcasting operates mostly ethnic and variety-formatted stations in Chicago, Detroit, Buffalo, Pittsburgh, Flint, Salisbury-Ocean City and Frederick (MD), and it holds the CP for the future WIJR, Palm Beach, Gardens, FL. Birach's latest pickups are adult standards "Magic 810" WMJH, a daytimer licensed for 3600 watts. And WMFN, with 2200-w day, 230 night, ND, at 640. Seller for both is Cook-Media II, LLC (John Shepard, Peter Cook). WMFN at 640 is currently doing a mix of talk, sports and standards.

lowa:

Lifestyle Communications' three Iowa stations are headed into court-appointed receivership. It appears that Clarke County State Bank in Iowa hauled Lifestyle Communications and related parties into court and got a receiver appointed on August 9. That's Thomas H. Burke, who will run the stations after the FCC grants his application. Unlike most receivership situations, the receiver in the case of broadcast licenses must get FCC permission to assume operation of the facilities. The three stations are classic country KIIC, Lamoni (97.9), sports KJJC, Osceola (107.1) and sports KLRX, Madrid, IA (96.1) and we presume Burke will be looking for a buyer, speedily.

Central Upper Michigan:

Marathon Media sells off II stations for nearly \$8M. Chris Devine and Bruce Buzil are dealing an II-station regional group to Northern Star Broadcasting, headed by President Palmer Pyle. His backers are Charles Knight and Wade Fetzer, both of Glen Arbor, MI, each with 44% of Northern Star. Here's the lineup: In Iron Mountain, talk/sports WMIQ, at 1450 and classic hits "K-Rock" WIMK (93.1). In Marquette, talk/sports WDMJ (1320) and classic hits WUPK at 94.1 (simulcasting WIMK). In Ishpeming, talk/sports WIAN (1240) and country WJPD (92.3). In Sault Ste. Marie, talk/sports WNMW at 1400 and CHR "Yes 99.5" WYSS. Plus talk/sports WNGE, Negaunee (99.5). Country WIHC, Newberry (97.9). And AC "Z94.3" WZNL, Norway. Total price: \$7,950,000.

Western Pennsylvania:


Marriott-backed First Media Radio pays \$4.2M for WCED and "Moo 102" WMOU-FM. We're used to watching Vox Radio Group buy assets, not sell them, but this DuBois, PA combo may be out of its geographical range. Who is First Media Radio LLC? The ownership group includes Alex Kolobielski, William E. Prettyman, Jr., and – notably — Richard Marriott. The Marriott family's First Media is a major investor in New Northwest Broadcasters. While the separate "First Media Radio, LLC" owns four other stations in Pennsylvania (WZWW, Bellefonte, WLAK, Huntingdon and Lewistown's WIEZ/WMRF-FM). Plus two in Easton, MD (WCEI-AM/FM). The stations First Media Radio is buying in DuBois are oldies WCED at 1420 (5-kw day, 500 night, DA-N). And class B "Moo 102" WMOU-FM at 102.1. Stamford-based Dick Foreman brokered the \$4.2M sale.

State College, PA:

Dame picks up classic hits "Bus" WBUS, Boalsburg as its fifth station around the home territory of the Penn State Nittany Lions. It also appoints WBUS GM Rob Schmidt as its GM of the new five-station cluster, including oldies WNCL. "The Bus" is WBUS, Boalsburg, a class A at 93.7, being sold by Boalsburg Broadcasting. Dame will co-locate all five stations in one facility.
